

### Argent Wealth Management, LLC – Form CRS

Argent Wealth Management, LLC (“we”, “our”, or “us”) is registered with the U.S. Securities and Exchange Commission (“SEC”) as an investment adviser. Our services and compensation structure differs from that of a registered broker-dealer. Free and simple tools are available to research firms and financial professionals at [www.investor.gov/CRS](http://www.investor.gov/CRS). The site also provides educational materials about broker-dealers, investment advisers and investing. Information in text boxes below are intended to be conversation starters for you to have with us and are required by the instructions to Form CRS.

#### *What investment services and advice can you provide me?*

We provide discretionary and non-discretionary investment advisory services to a variety of retail investors, which generally include individuals and their trusts and estates. We may also be separately engaged to provide financial planning, tax advice, consulting and trustee services.

For investment advisory services, we first determine your investment objective, and then invest or recommend that you invest your assets according to your investment objectives. Once invested, we monitor and review your account performance and asset allocation, and may rebalance or recommend that you rebalance as necessary based on these reviews.

More frequently we provide our services on a discretionary basis, which means we have the authority to buy and sell investments in your account without speaking to you prior to doing so. We also provide our services on a non-discretionary basis, which means we require your consent before engaging in a course of action. You can place reasonable restrictions on the securities and types of securities that we buy by notifying us, in writing.

We do not limit the scope of the universe of securities that we use in managing client accounts, although we generally invests in various debt (bonds) and fixed income securities, equity securities, mutual funds and exchange traded funds (“ETFs”), and private funds. We may also recommend independent managers.

We do not require a minimum annual fee, but generally require a minimum account size of \$1,000,000 for investment advisory services, although in certain circumstances a minimum fee is negotiated in advance with clients.

#### *What fees will I pay?*

Our fee for investment advisory services is based on a percentage of your assets under our management, begins at the annual rate of 1.0%, and decreases the more assets that you entrust to our management. We deduct our fee from one or more of your investment accounts on a quarterly basis, in advance, based upon the market value of the assets on the last business day of the previous quarter, subject to adjustment for inflows and outflows. Because our fee is based on the amount of your assets under our management, the more assets you entrust us to manage, the more you will pay us for our services. Therefore, we have an incentive to encourage you to increase the amount of assets that you entrust to us.

We generally negotiate our fees with clients on either a fixed fee or hourly rate basis for those clients who engage us for planning, consulting, and tax-related services.

Your account will be held with a qualified custodian. Custodians generally charge transaction fees for effecting certain securities transactions. In addition, your assets can be invested in mutual funds and ETFs and other pooled investment vehicles. You will bear your pro rata share of the investment management fees and other fees of the funds, which are in addition to the fees you pay us. These fees and expenses are described in each fund’s prospectus or offering document and potentially include a management fee, distribution fee, and other fund expenses. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

***What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?***

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

- \* We may recommend a particular custodian from whom we receive support services. This presents a conflict of interest, because our receipt of their support make us more inclined to continue using and recommending them.
- \* We may recommend rollovers out of employer-sponsored retirement plans and into Individual Retirement Accounts that we manage for an asset-based fee. If we don't currently manage your account held with your employer's plan, this will increase our compensation.
- \* Certain persons associated with us are licensed attorneys and practice law. We may recommend their services which presents a conflict of interest. No client is under any obligation to engage these individuals.

***How do your financial professionals make money?***

Our financial professionals are generally compensated on a salary basis and may receive discretionary bonuses. In the event an employee earns a bonus, they are based on various factors. Certain eligible employees are also able to receive cash bonuses for referring clients to us. In addition, certain of our financial professionals are equity owners of the firm, in which case they stand to receive a share of the profits of the firm.
